Position Summary

The Sanctuaries Manager is an exciting opportunity for someone who is looking for a role that is directly involved in the creation of a positive and safe environment for all of Bird Alliance of Oregon's staff, volunteers, program participants, and general public helping pave the way for the organization to continue its focus and commitment to its mission: to inspire all people to love and protect nature.

The Sanctuaries Manager balances conservation, education, research, habitat improvement and recreation, while managing Bird Alliance of Oregon's sanctuaries and natural areas. This includes land in Multnomah, Clackamas, and Lane Counties totaling approximately 479 acres, and roughly 5 miles of hiking trails. The Sanctuaries Manager is a member of the Operations team, and reports to the Assistant Director of Facilities & Sanctuaries. This is a full-time position. Must be able to work after-hours, nights, and weekends, and respond to emergencies as necessary. The duties of the Sanctuaries Manager include, but are not limited to the following:

Essential Duties & Responsibilities

- Develop and implement sanctuary plans for the Bird Alliance of Oregon sanctuaries, in collaboration with the Conservation and Education teams and outside partners.
- Manage existing hiking trails and implement new trail system designs
- Manage restoration and invasive species removal projects per sanctuary plans
- Collaborate with partner organizations like Trailkeepers of Oregon on trail projects
- Supports the Assistant Director of Facilities & Sanctuaries with sanctuary-oriented capital projects, when relevant
- Monitors and maintains the internal work-order system, responding to sanctuaries related requests in a timely manner
- Collaborate with the Development Dept. on grant proposals
- Supervises the Facilities and Sanctuaries
 Technician for sanctuary related projects

- Develops and manages monthly, seasonal, and annual volunteer projects and weekly volunteer events like the Wednesday Work Crew
- Collaborates with the Assistant Director of Facilities & Sanctuaries and the Education Department on a workforce development program centered around restoration work in the Bird Alliance of Oregon's sanctuaries
- Performs inspections, maintenance and basic repairs on built structures, such as: boardwalks, bridges, gabions, and shelters.
- Respond to weather-related emergencies and security related incidents
- Address sanctuary-related inquiries and complaints as necessary
- Apply equity lens to work and be accountable for ensuring equitable practices
- Actively participate in the organization's Safety Committee as needed

Preferred Skills & Experience

- Bachelor's degree in environmental studies, land use planning, natural resource management, ecology/biology, forestry, related field, or substantial experience in a related field
- Minimum 4+ years relevant experience
- Working knowledge of plant phenology, especially native and invasive species to the Pacific Northwest
- Experience working with volunteers, interns, and/ or community groups in restoration activities
- Experience building or maintaining Class 2-3 hiking trails

- Experience using GIS systems and GIS mapping
- First Aid/CPR training or ability to acquire certification
- A-Sawyer (chainsaw) or greater certification or ability to acquire certification
- Must have a valid Class C driver's license to operate company vehicle(s) as needed
- Experience with Google Suite a plus
- Excellent organizational skills
- Excellent verbal and written communication skills

Work Environment and Requirements

- Bending at waist, sitting, kneeling, walking, crouching as job may require
- Ability to lift up to 75 pounds
- Ability to work year round in adverse weather conditions
